Registration, Tuition & Competition Payment Schedule

Each participant is required to pay a registration fee to Iconic Allstars to join. In addition to your monthly team tuition, Allstars will also be collecting the combined payment of your cheerleaders' competition fees, choreography fee, music fee, USASF membership fee, coach fee, etc.

- Cheer Shoes (approximately \$100.00 or use your own clean white shoes)

~All fees must be paid prior to our first competition or your child will not participate

~The CC on file will be charged on the 2nd or 16th of the month if your payments are late

~ Credit Card charge of \$25 NSF fee will be posted if we are not able to process the payment(s)

~A \$15 late fee will be posted to each account the day after it is due if payment is not received
